CAPE – Academic –Prospectus for admission to B.Tech course under NRI quota in the Engineering Colleges under CAPE for the academic year 2013-14– Amended – Orders issued.

ORDER

As per the reference read as 2nd paper above, Government in Higher Education (G) Department have amended the academic eligibility for admission to B.Tech courses prescribed in the Prospectus KEAM'2013.

In the above circumstances, the Prospectus for admission to B.Tech course under NRI quota in the Engineering Colleges under CAPE for the academic year 2013-14 has been modified incorporating the following Clauses as 8.1 (a) and 8.2 (a) in addition to Clause 8.1 and 8.2 respectively.

- Clause 8.1 (a): "Candidates who have passed Higher Secondary Examination,
 Kerala or Examination as equivalent thereto, with 60% aggregate
 marks in Physics and Chemistry/ put together and 45% marks in
 Mathematics are also eligible for admission to B.Tech Degree course".

 (in case candidate has not studied Chemistry, marks obtained in Computer
 Science shall be considered. In case the candidate has not studied Chemistry
 and Computer Science, marks obtained in Biotechnology shall be considered.

 In case the candidate has not studied Chemistry, Computer Science and
 Biotechnology, the marks obtained in Biology shall be considered).
- Clause 8.2 (a): ``SEBC and PD candidates who have passed Higher Secondary

 Examination, Kerala or Examination as equivalent thereto, with 55% aggregate marks for the optional subjects put together are also eligible for admission to B.Tech Degree course. They need only 40% marks in Mathematics``.
