As per the Executive Committee decision read as 1<sup>st</sup> paper above, it has been ordered that the Trade Instructor Grade-II after successful declaration of Probation shall be promoted as Trade Instructor Grade-I in the scale of pay of Rs.14620-25280 (PR) against vacancy. Government in Co-operation (B) Department as per the G.O read as 2<sup>nd</sup> paper above has approved 16 posts of Trade Instructor Grade-II in various Departments and revised the scale of pay to Rs.27800-59400. Accordingly as per the Proceedings read as 3<sup>rd</sup> paper above, 1 post of Trade Instructor Grade-II (Carpentry) has been earmarked for promotion to the post of Trade Instructor Grade-I (Carpentry).

Sri.Rajan.K , Trade Instructor Grade-II (Carpentry) stands 1<sup>st</sup> position in the seniority list of Trade Instructor Grade-II (Carpentry) and he has completed his probation in the lower post satisfactorily. He is found eligible for promotion as Trade Instructor Grade-I (Carpentry).


## ORDER

In the circumstances, Sri.Rajan.K, Trade Instructor Grade-II (Carpentry) is promoted as Trade Instructor Grade-I (Carpentry) in the scale of pay of Rs.27800-59400 and posted in the present station until further orders.

Sri.Rajan.K will be on probation in the promoted post of Trade Instructor Grade-I (Carpentry) for a continuous period of one year from the date of joining duty.
